This 9-hole league is for groups who want a standing tee time for the golf season. You must have a minimum of four golfers and commit to a 25, 22 or 20-week session. Tee times available Monday-Thursday.

25-Week Session (Tee Times Between 4:03pm - 5:15pm) March 11-August 29, 2024 22-Week Session (Tee Times Between 5:24pm - 5:51pm) April 1–August 29, 2024 20-Week Session (Tee Times Between 6:00pm – 6:27pm) April 15–August 29, 2024

League Requirements

We set aside standing tee times for our Corporate Leagues, so it's important that they don't go unused. Performance, based on the guidelines below, will determine good standing or possible forfeiture of 2024 tee times, as well as tee time selection going into the 2025 season.

- Commit to a full session (25-week, 22-week, or 20-week)
- Perform at 75% fill rate for your tee times each week
- Send player names to the course by 12:00 p.m. on the day of play
- Maintain a pace of play of 2:15 or under

CORPORATE LEAGUE REQUEST FORM

All groups wishing to register for a Corporate League at St. Andrews or Sykes/Lady Overland Park Golf Course <u>must return</u> this completed and signed form to the applicable golf contact listed below.

Performance Clause:

- Adjustments to the requested number of golfers may be made each week without penalty by informing the golf pro before noon on the day of play.
- In order to retain the tee times, the league representative must submit a tee sheet showing the specific players' names assigned to the specific tee times to the golf course starter. This list must be received by noon on the day of play.
- 2024 leagues must perform at 75% or better fill rate to secure the same tee time in 2025. Performance tracking (golfers reserved vs. golfers that actually played) will be recorded weekly. A league's ability to maintain preferred tee times from year-to-year can be affected by their participation performance.
- The City of Overland Park reserves the right to fill all unused tee time slots.
- 2024 leagues must maintain an appropriate pace of play of no longer than 2:15 for nine holes.

- 25-Week Session (Tee Times Between 4:03pm 5:15pm) March 11-August 29, 2024
- 22-Week Session (Tee Times Between 5:24pm 5:51pm) April 1–August 29, 2024
- 20-Week Session (Tee Times Between 6:00pm 6:27pm) April 15–August 29, 2024
